Is the responsibility of the exhibitor. Table-top exhibits only. Your display must fit into a 6' x 6' foot space. There is no room for complicated exhibits (no large furniture or equipment, etc. except for prime spaces that will have an 8' x 8' space). Placement of displays must be done to avoid blocking the visibility of neighboring exhibitors. Exhibitors will be asked to move their exhibit should there be any complaints.

### What if I need electrical?

### Loading/Unloading into the Exhibit Hall

There is a loading dock at the Hotel; however, it is on the other side of the property from Talisa Ballroom. Smaller deliveries should go to the loading dock, which is located underneath Zermatt Ballroom and can be brought up to the meeting space from there. You may unload and set up anytime between 7:30-11:30 a.m. On Tuesday, May 14.

### Dedicated Expo Hours

### Cancellation Policy

Exhibit registrations not paid in full by April 16 will be cancelled. Exhibit registrations received on April 16 or after must be paid in full at time of registration. Exhibit registrations cancelled prior to April 16 are subject to a \$500 cancellation fee. No refunds will be offered after April 16.

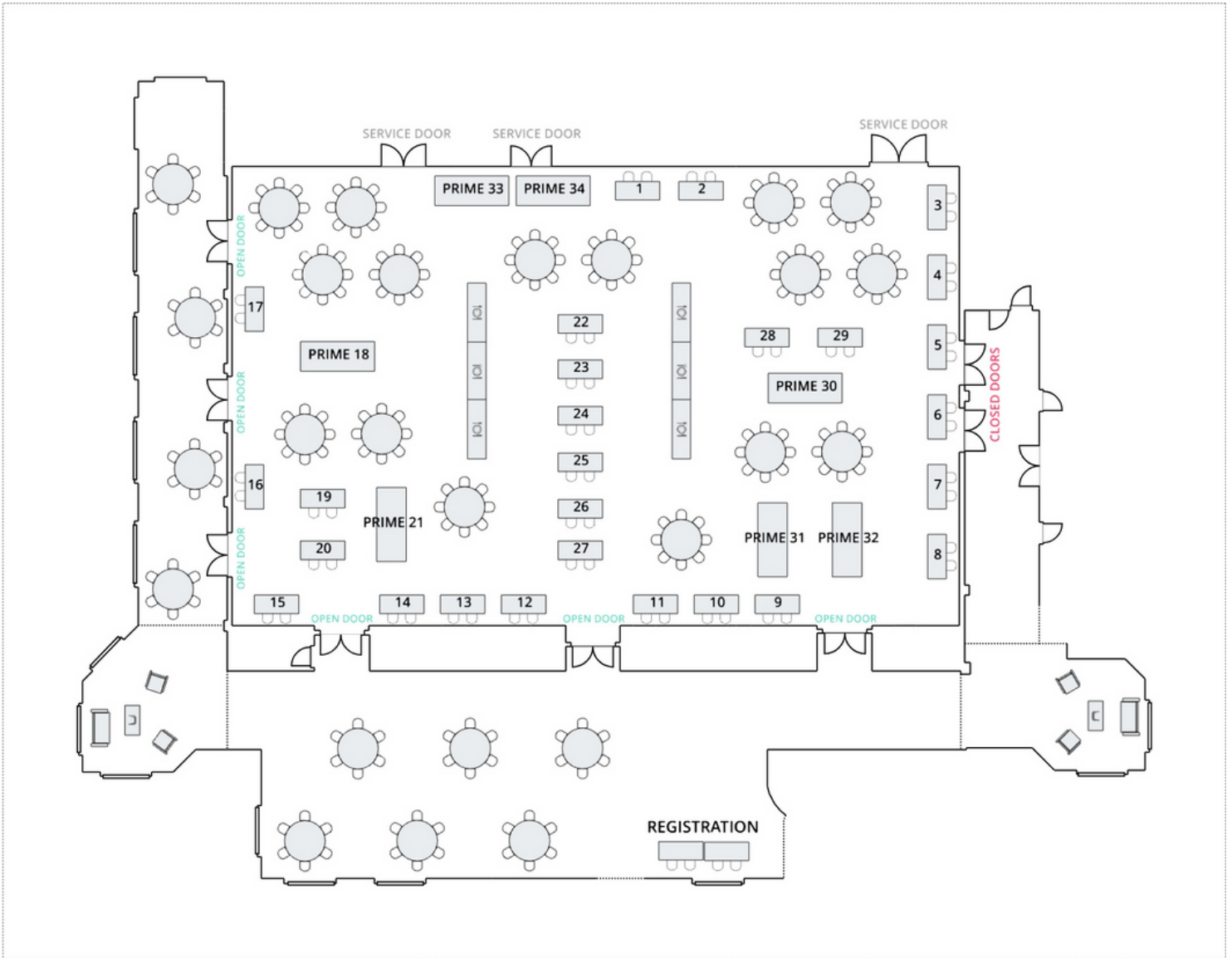
