EXHIBIT CONSTRUCTION

Is the responsibility of the exhibitor. Table-top exhibits only. Your display must fit into a 6' x 6' foot space. There is no room for complicated exhibits (no large furniture or equipment, etc. with the exception of premium spaces that will have a 8' x 8' space with a cocktail table). Placement of displays must be done to avoid blocking the visibility of neighboring exhibitors. Exhibitors will be asked to move their exhibit should there be any complaints.

SECURITY

Although limited security will be provided, exhibitors must provide for the security of their goods, materials, equipment and general display at all times. LeadingAge Colorado will not be responsible for the loss or damage of any material for any cause.

PROGRAM LISTING

To be listed in the conference program, exhibitor contracts must be received and paid for by Friday, April 14, 2023.

MEALS AND MISCELLANEOUS

LOADING/UNLOADING INTO EXHIBIT HALL

There is a loading dock at the Hotel; however, it is on the other side of the property from Talisa Ballroom. Smaller deliveries should go to the loading dock, which is located underneath Zermatt Ballroom and can be brought up to the meeting space from there.

You may unload and set up anytime between 1:30-3:30 p.m. On Tuesday, May 16.

CANCELLATION POLICY

Exhibit Fee and Cancellation Policy - No exhibit space will receive permanent assignment without receipt of full payment. If an assigned space is cancelled on or before **April 8, 2023**, \$300 of the total cost will be retained by LeadingAge Colorado. If assigned space is cancelled by the exhibitor after **April 8, 2023**, all moneys paid will be retained by LeadingAge Colorado. There will be no refund for advertising or sponsorship fees. Event cancellation by LeadingAge Colorado, if required, will include a full refund.

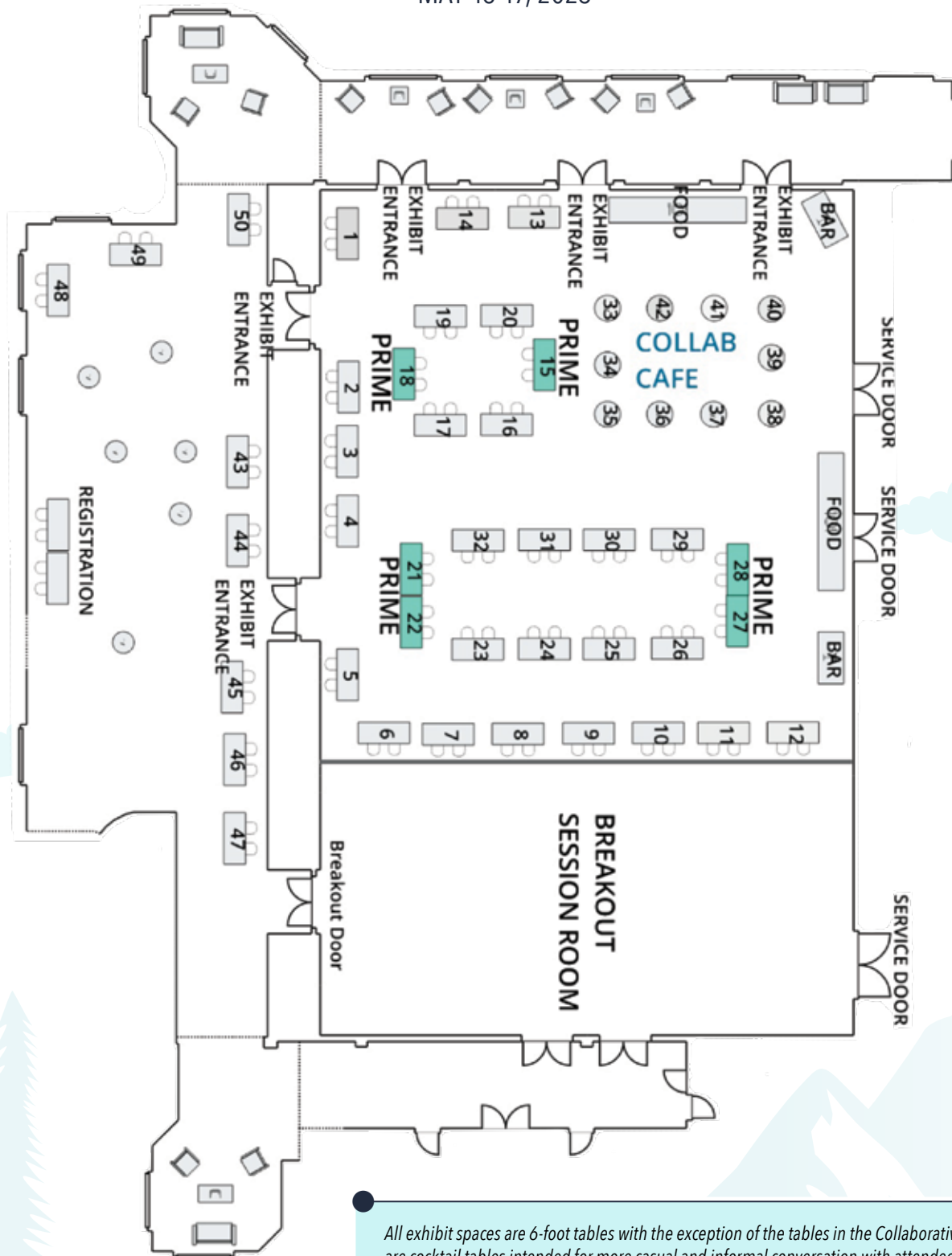

Exhibit Hall Foyer Floor Plan

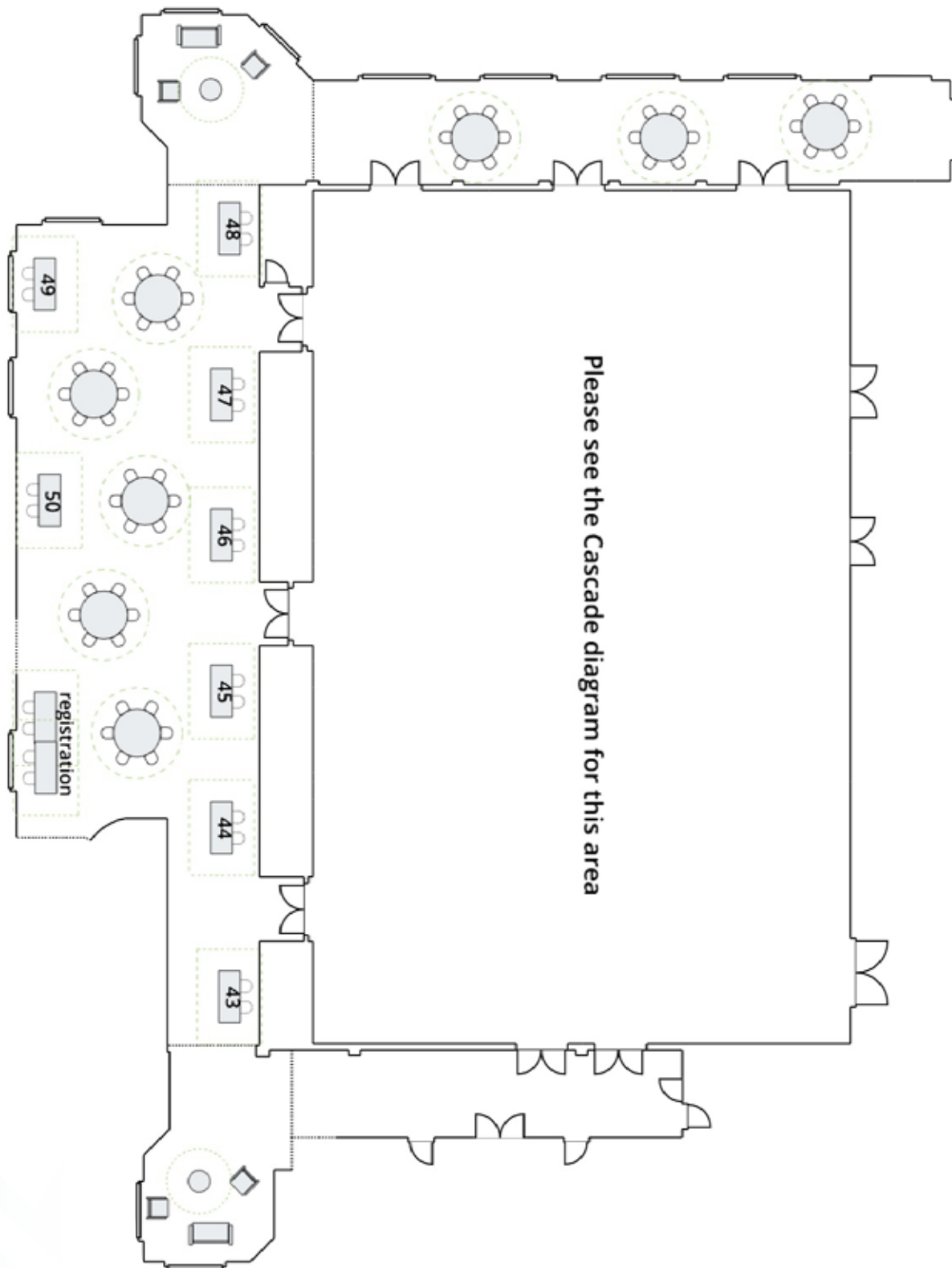

Exhibitor will indemnify, defend, and hold harmless LeadingAge Colorado, the Hotel, its owner, its agents, management company, as well as their respective officers, directors, agents, servants, and employees from any and all such losses, damages and claims.
